



Food Service Management Recertification Courses

This course is designed for students who have already received a certificate from a previous food service management certification course and need to become recertified due to an expired certificate. This course covers the same material as the 16-hour course; however it is in an abbreviated format. The class is designed to have four (4) hours of course lecture and review.

? WHO MAY ATTEND: Restaurant operators, food service managers, or anyone interested in food service sanitation **that has prior certification** is welcome. If a certificate is more than ten (10) years old, it is recommended that the full 16-hour certification course be taken.

Students **MUST** provide a copy of their previous certificate from a State of Michigan approved food service management certification course at the time of registration.

📅 ATTENDANCE: Attendance is **REQUIRED** for the duration of the class. Late arrivals will be required to re-enroll in another available recertification course.

🕒 CLASS TIME: All classes begin at 8:30 a.m. with an hour lunch break around 12:30 p.m. The exam will start immediately following the lunch break. See schedule below for class dates.

👋 REFUNDS: Once enrolled for a class, there will be **NO refunds**. Students are not permitted to transfer to another class unless arrangements are made 10 days prior to the start of the class they are enrolled in.

✍️ TO REGISTER: Complete the attached registration form and mail or deliver to OCHD with the appropriate fee and a copy of your previous certificate. Classes fill quickly, therefore, early registration is recommended.
